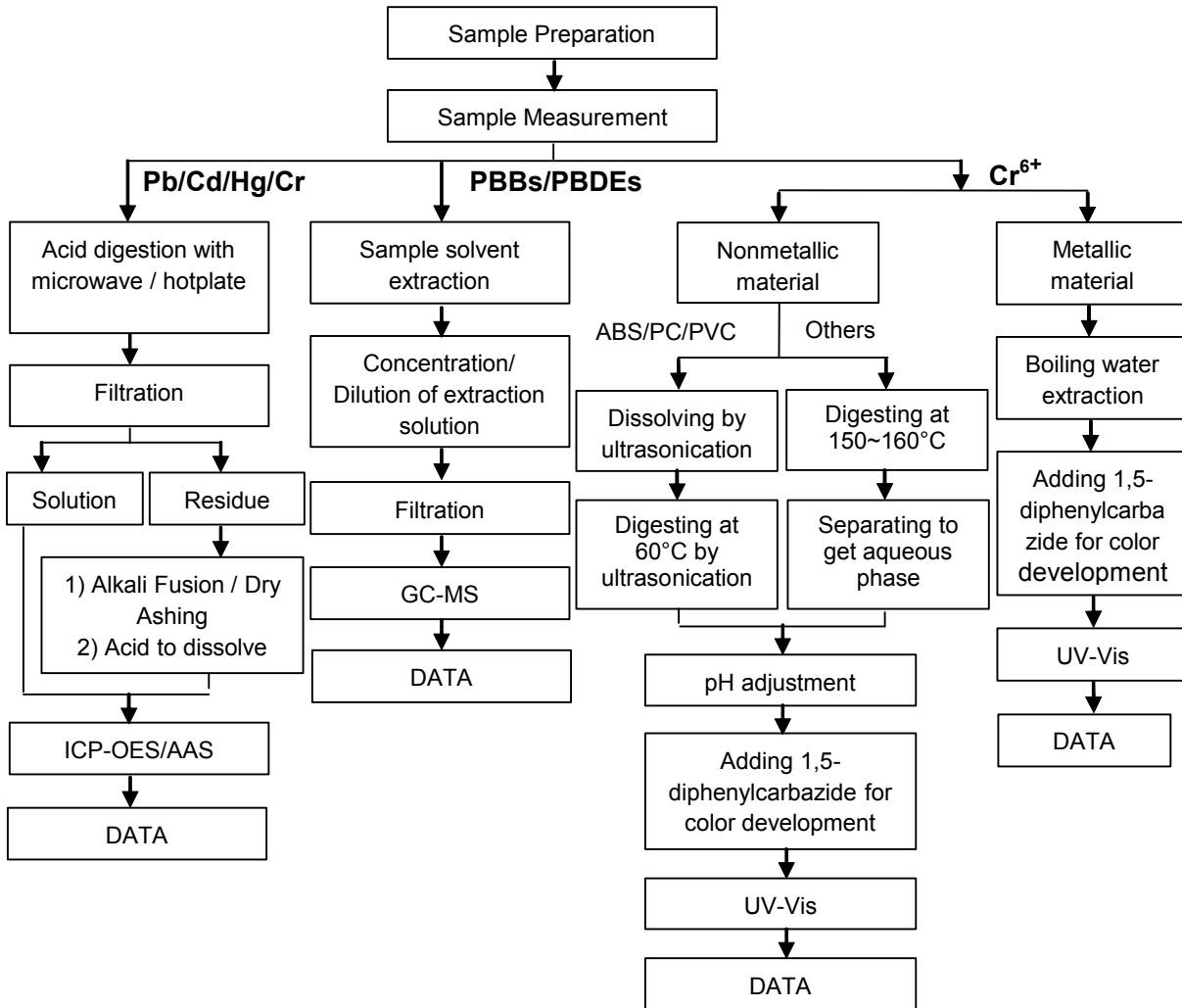

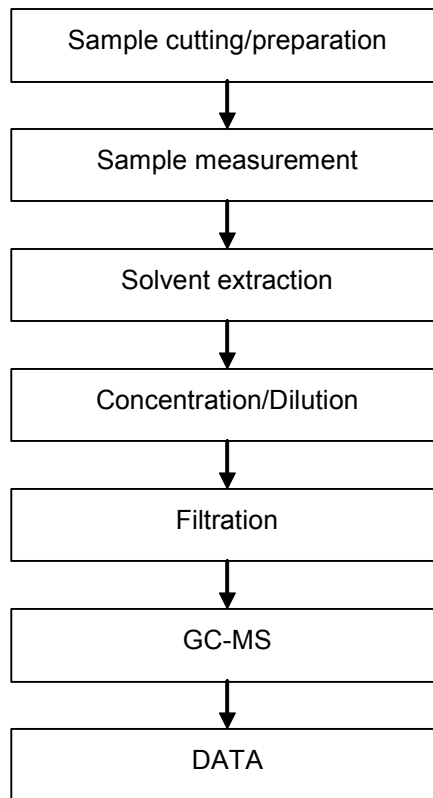

Phthalates Testing Flow Chart

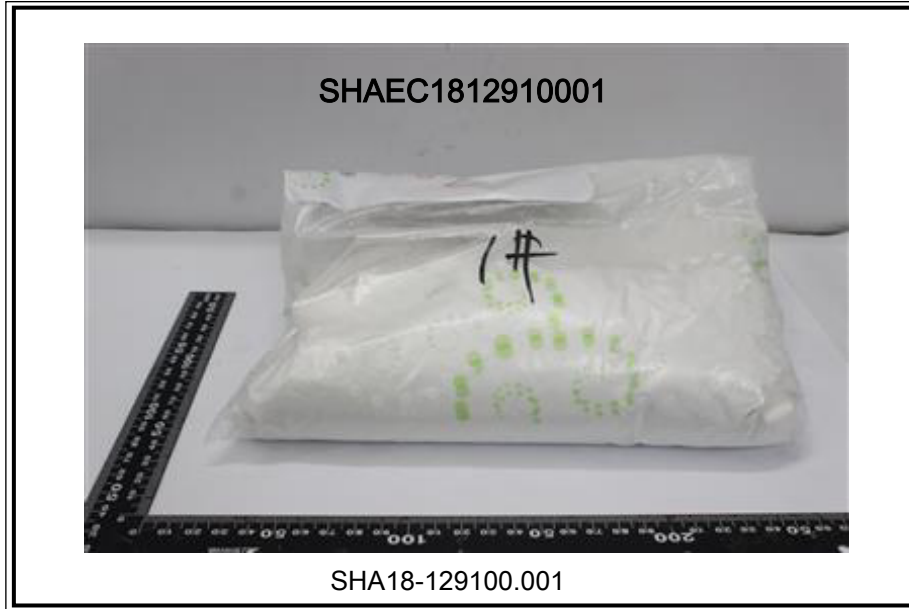

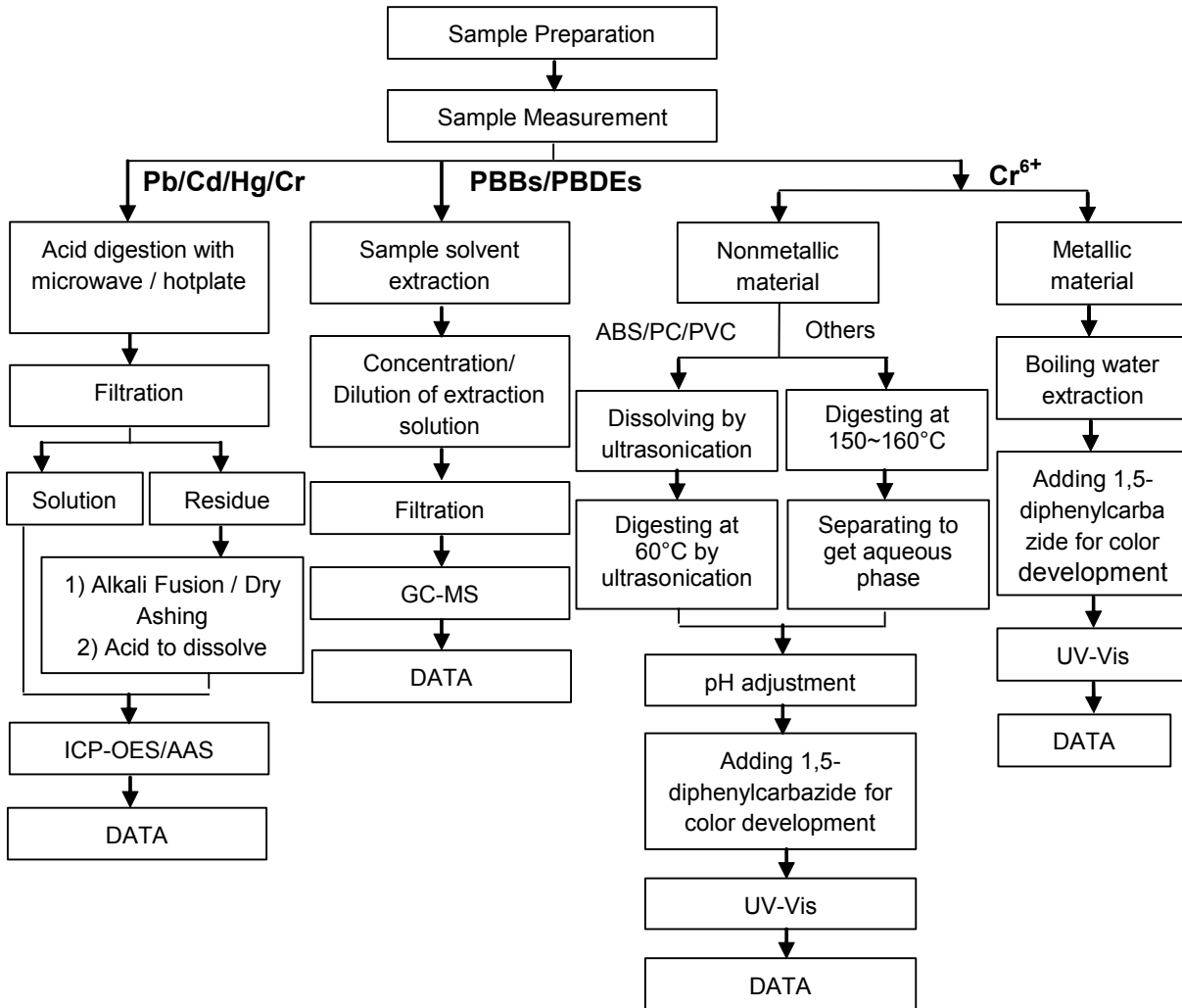

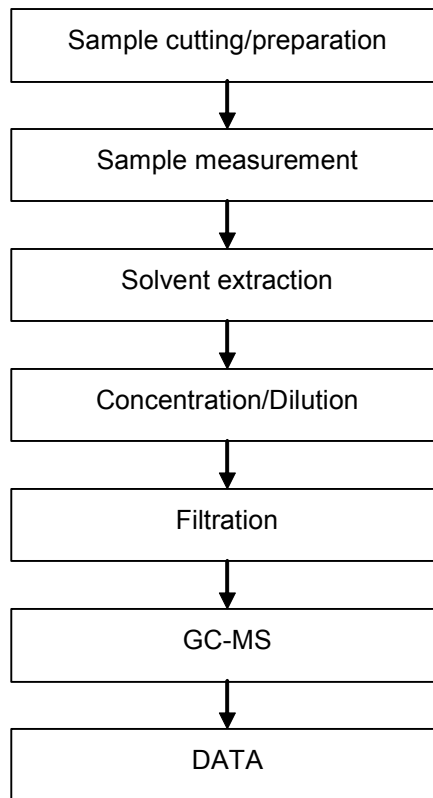

Phthalates Testing Flow Chart

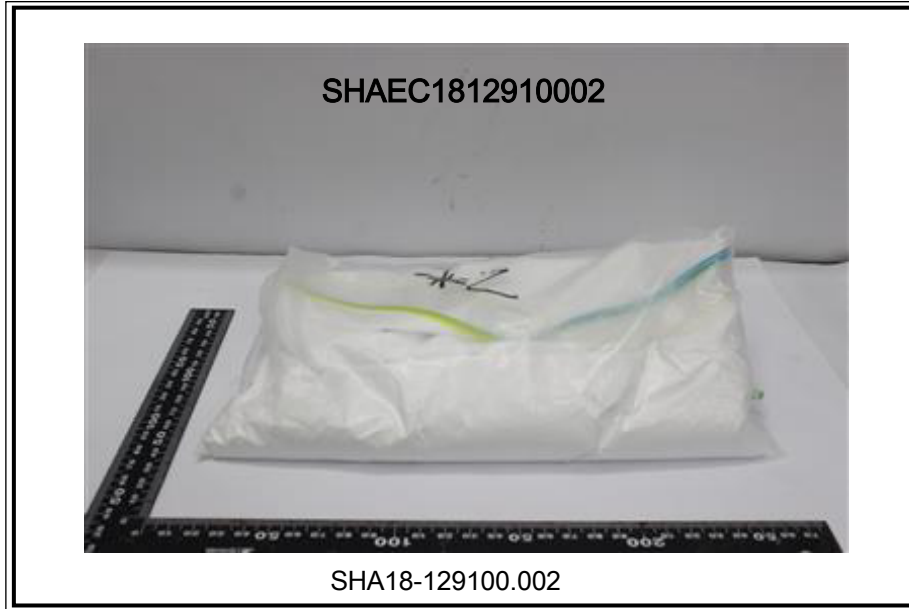
